1 Estimates and Expenses

Our estimates set out the services we agree to supply. This estimate is an indication of the charges likely to be incurred on the basis of the information and details we know at the date of the estimate. While we make every effort to ensure the accuracy of the estimate, the charges are liable to alteration particularly where third parties change their rates or charges.

We may not know the amount of the third party charges in advance of the funeral; however, we give you a best estimate of such charges in the written estimate. The actual amount of the charges will be detailed and shown in the final account.

If you amend your instructions we will require your written confirmation of the changes. We may need to make an extra charge in accordance with the prices published in our current price list.

2 Payment Arrangements

The payment of the funeral account is the responsibility of the person who arranged the funeral.

The 'Estimated Funeral Account' is due for payment at least 7 days prior to the funeral (the due date). If full, cleared payment is not received by this time, we reserve the right to postpone or cancel the funeral without notice.

If you fail to pay us in full on the due date we may charge you interest:

- at a rate of 8% above our bank's Base Rate from time to time in force;
- calculated (on a daily basis) from the date of our account until payment;
- compounded on the first day of each month; and
- before and after any Judgement (unless a Court orders otherwise).

We may recover (under Clause 3) the cost of taking legal action to make you pay.

3 Indemnity

You are to indemnify us in full and hold us harmless from all expenses and liabilities we may incur (directly or indirectly including financing costs, and including Legal costs on a full indemnity basis) following any breach by you of any of your obligations under these Terms.

This means that you are liable to us for losses we incur because you do not comply with these Terms. For example, we may charge you an administration fee where we receive a cheque from you which is subsequently not honoured or if we write to remind you that an account is overdue. If we instruct debt collection agents we may also recover from you the fees we incur. Further details regarding these fees are available on request. We may claim those losses from you at any time and, if we have to take legal action, we will ask the Court to make you pay our legal costs.

4 Data Protection

Words shown in italics are defined in the Data Protection Act 2018 ("the Act").

We respect the confidential nature of the information given to us and, where you provide us with personal data ("data") we will ensure that the data will be held securely, in confidence and processed for the purpose of carrying out our services. In order to provide our services we may need to pass such data to third parties and those third parties, who are performing some of the services for you, may contact you directly. Under the Act you have the right to know what data we hold on you and you can, by applying to us in writing and paying a fee, receive copies of that data.

5 Cooling-Off Period

The Cancellation of Consumer Contracts made in the Consumer's Home or Place of Work etc Regulations 2008 may give you the right to terminate an agreement with us in the cooling-off period of seven days. If you wish the performance of the agreement to which this right applies to commence before the end of the cooling-off period, you must sign the authority in the form which will be handed to you.

All dates and times provided on the estimate cannot be guaranteed until final booking are made and confirmed. Although we endeavour to provide a prompt and efficient service to you, there may be instances where, because of circumstances beyond our control, we are unable to fulfil our obligations to you on the date or time specified. Where this is the case we will attempt to contact you in advance, using the details overleaf, and advise you of alternative arrangements.

8 Agreement

Your continuing instructions will amount to your continuing acceptance of these Terms of Business. Your instructions will not create any right enforceable by virtue of the Contracts (Rights of Third Parties Act 1999) by any person not identified as our client.

If any of these terms are unenforceable as drafted;-

- it will not affect the enforceability of any other of these Terms; and
- if it would be enforceable if amended, it will be treated as so amended.

Nothing in these Terms restricts or limits our liability for death or personal injury.

This agreement is subject to English Law. If you decide to commence legal action, you may do so, in any appropriate UK Court.

9 Collection of Ashes

- 9.1 The Client undertakes to arrange (where applicable) for the collection of the ashes of the Deceased within 60 days following cremation of the Deceased.
- 9.2 In the event that the ashes have not been collected within the time referred to in Clause 9.1 then the Client authorises Rounce Funeral Services Limited to charge £30 per month or part-month for storage until the Client collects them.
- 9.3 In the event that the ashes have not been collected within 12 months following cremation of the Deceased then the Client authorises Rounce Funeral Services Limited to dispose of the ashes without any further notice to the Client.
- 9.4 The Client undertakes to indemnify Rounce Funeral Services Limited against the claims of any third party which may arise out of the disposal of the ashes as contemplated in Clause 9.3.
- 10 Disclaimer Family and Friends acting as Pallbearers
- 10.1 Where the Client undertakes to arrange family and friends to conduct the pall bearing to carry the Deceased on a funeral, in no event will Rounce Funeral Services Limited be liable for any injury, accident or damage whatsoever arising out of, or in connection with carrying the Deceased in a coffin.
- 10.2 The Client undertakes to indemnify Rounce Funeral Services Limited against the claims of any third party which may arise out of the carrying of the Deceased as contemplated in Clause 10.1.

11 Pricing Structure

11.1 Service Charge – Our overall fee for arranging and conducting the funeral.

11.2 Coffin Charge – The cost of the coffin selected, which includes our purchase cost and a small margin. Together, these two elements make up the total fee you pay for essential services, not including disbursements and any other goods and services that you select.

12 Profit Allocation

12.1 We split our profit margin between the Service Charge and the Coffin Charge.

12.2 Every coffin we supply carries a modest profit margin, which helps us maintain the highest standards of quality and service and allows us to keep our headline price competitive.

13 Use of Externally-Purchased Coffins

13.1 You may choose to source your own coffin ("External Coffin") but we would recommend that you get Rounce to buy it for you so that we can ensure it fits correctly, adequately supports the weight and complies to all current regulations.

13.2 Any External Coffin must comply fully with current UK regulations for burial and/or cremation, including: EN 13485 certification for burial coffins, and/or BS EN 15289 certification for cremation coffins.

13.3 If you choose to purchase your own External Coffin and it does not meet these standards, we will require you to provide valid certification before use.

13.4 Supplementary Charge – To preserve our agreed profit margin, should you supply an External Coffin, we reserve the right to add up to £300 to our Service Charge.

14 Examples

Our Coffin: If our coffin price is £800 (including our margin) + Service Charge £1,200, your total is £2,000. Your Coffin: If you buy a coffin externally, you pay the coffin supplier directly and our Service Charge of £1,200 + up to £300 supplementary charge = up to £1,500.

If you want Rounce to buy an External Coffin, we pay the supplier directly and our Service Charge of £1,200 + cost of coffin + up to £300 supplementary charge.

15 Acceptance
